**Season Dates:** Tribal Member: 11/05/16-12/11/16      Indian Non Member: 11/12/16-12/04/16      Non-Indian: 11/19/16-12/04/16

**Fees:** A 4% Tribal Tax will be required of all license purchases excluding the surcharge.  
\$10.00 S&H Fee unless picked up in person.

**Tribal Member:** \$25.00    **Indian Non Member:** \$275.00 + 4% tax = \$286.00    **Non-Indian:** \$300.00 +4% tax = \$312.00    **Affiliate:** \$150.00 + 4% tax = \$156.00

**Surcharge:** A \$5.00 surcharge is assessed to the first "2016" license purchase. Any additional "2016" license purchases will not be subject to the surcharge.

**Limit:** One (1) Any White Tail Deer.

**Antler Restriction:** Must be at least a 3x3 if antlered

**Affiliate eligibility:** A non member employed by the Sisseton Wahpeton Oyate or a nonmember employed by a local government which provides services to the Sisseton Wahpeton Oyate. Any non member who is enlisted full-time in the US Armed Forces or National Guard is also eligible for affiliate prices.

**Hours:** One half-hour before sunrise to one half-hour after sunset.

**Permits:** (115) Non Indian Permits. Valid on Trust lands on the Lake Traverse Reservation on South Dakota side only. No hunting allowed on Lake Traverse Reservation trust lands on the North Dakota side unless a special permit is acquired from the SWO Fish & Wildlife Department through a separate application process. These special permits are available on a first come basis limited to (15) permits.

**Zones:**    Zone No. I – Tribal and Trust lands within the original boundaries of the Lake Traverse Reservation, north of Highway 10 to the North Dakota Border. (58) PERMITS AVAILABLE.

Zone No. II – Tribal and Trust lands within the original boundaries of the Lake Traverse Reservation, south of State Highway 10 to the point at Lake Kapeska by Watertown. (57) PERMITS AVAILABLE.

**Hunter Report Cards:** All hunters are required to submit a hunter report card within 15 days of the close of the season. Year 2015 hunters who did not submit a hunter report card will be penalized a \$10.00 penalty fee which will be assessed to their 2016 license purchase. May submit in office or online at <https://wso.nagfa.net/online>.

**Color-coded Tribal Hunter Atlases:** Available upon request for \$25.00 ea.

**Payment:** Credit Card, Debit Card or Checks are accepted. Personal checks will be processed by E-Check. Cash is accepted if applying in person. Do not send cash in the mail. Please make checks payable to SWO Fish & Wildlife Dept.

**Refunds:** Any unsuccessful applicant will be refunded their payment. No license may be refunded or transferred after being issued. No refunds on Hunter Atlases.
