Limit: One (1) Any White Tail Deer

Fees: A 4% Tribal Tax will be required of all license purchases excluding the surcharge.

Tribal Member:	\$20.00	= \$20.00
Indian Non-Member	\$195.00	+ 4% tax = \$202.80
Non-Indian	\$250.00	+ 4% tax = \$260.00
Affiliate	\$125.00	+ 4% tax = \$130.00

Surcharge: A \$5.00 surcharge is assessed to the first "2016" license purchase. Any additional "2016" license purchases will not be subject to the surcharge.

S&H Fee: \$10.00 unless picked up in person.

Affiliate eligibility: A non member employed by the Sisseton Wahpeton Oyate or a nonmember employed by a local government which provides services to the Sisseton Wahpeton Oyate. Any non member who is enlisted full-time in the US Armed Forces or National Guard is also eligible for affiliate prices.

Hours: One-half hour before sunrise to one half-hour after sunset.

Hunter Report Cards: All hunters are required to submit a hunter report card within 15 days of the close of the season; these may be also submitted online. Year 2015 hunters who did not submit a timely hunter report card will be penalized a \$10.00 penalty fee which will be assessed to their 2016 license purchase.

Color-coded Tribal Hunter Atlases: New updated Tribal Atlases are available for \$25.00 ea.

Payment: Credit Card, Debit Card or Checks are accepted. Personal checks will be processed by E-Check. Cash is accepted if applying in person. Do not send cash in the mail. Please make checks payable to SWO Fish & Wildlife Dept.

Refunds: Any unsuccessful applicant will be refunded their payment. No license may be refunded or transferred after being issued. No refunds on hunter atlases.
