### **Project Information:**

Striping to be completed on BIA Route's 7, 2, 3, 5, 8, 15, 901. in Roberts County of the Lake Traverse Reservation.

### **Statement of Work:**

For this project the contractor shall be required to supply all labor, materials and equipment to complete the project which will conform to (SOUTH DAKOTA STANDARD SPECIFICATIONS FOR ROADS AND BRIDGES, 2015 EDITION AND REQUIRED PROVISIONS, SUPPLEMENTAL SPECIFICATIONS AND SPECIAL PROVISIONS, OR AS OTHERWISE NOTED IN THE PLANS).

### **This project shall consist of:**

4" Yellow and 6" White Durable paint markings on BIA Route's, 2, 3, 5, 15, 901 as noted in the plans. Object arrows and crosswalks on BIA Route's 7 and 8 cold applied plastic pavement markings and grooving as noted in the plans. These are included in the list of BIA Federal Routes on the Lake Traverse Reservation. Quantities are included in the plans. Also, include brooming as needed.
