## **Essential Functions:**

• Document and monitor client's attendance at all scheduled meetings and treatment functions.

- Be alert to clients, health, welfare and safety and make proper referrals/contacts when necessary.
- Enforce the Dakotah Pride Center's client rules and responsibilities and document through write ups any rule infractions and report incidents to the Clinical Supervisor and assigned Counselor.
- Assist in assigning and supervising daily client work/task schedule.
- Wake clients at assigned times and monitor their completion of assigned tasks.
- Maintain daily written reports of clients' progress, including any problems, negative attitudes or behaviors or inappropriate comments which contradict treatment efforts. Submit reports to assigned staff.
- Attend and participate in all staff meetings, in-service trainings and workshops sponsored by Dakotah Pride Center.
- Maintain and use the daily log and journal system as a communication tool for the treatment team.
