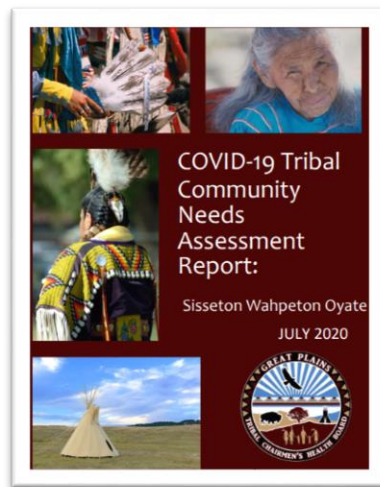

Pandemic Response

Writing about what we have been experiencing since March, especially the most recent months, is not easy. Our families are grieving, our Oyate is hurting for one another. No one can be ready for something so devastating, all we can do is reach deep down inside and do what we think is best in the current circumstances. Our love and resilience continue to shine through as individual and coordinated efforts to help each other in this difficult time are keeping more than food on tables, its keeping hope for better days ahead as we are realizing it is in our nature to care for our neighbors and this energy is growing. What is nurtured will grow; Dakota values are more than words, they are a way of life and we are witnessing just how alive and well our ancestors teachings are.



The SWO Research office's main responsibility is to protect human subjects. When the shut-down order was implemented in March the office didn't waste any time and began full-time remote working understanding that the nature of the research work meant that it must be prepared for public health research to come. The research community enacted emergency procedures across the world. Many projects halted completely while others were detrimental to people's lives and had to continue with no time to spare, beginning the changes to be made in how the research would

continue with human subject protections per safety procedures. Soon after a basic understanding of what the world was facing there were two COVID-19 protocols that the SWO LRRB reviewed; the Great Plains Tribal Chairmen's Health Board (GPTCHB) COVID-19 Tribal Community Needs Assessment, & the North East Youth Collaborative and Aliive Roberts County (NEYC/ARC) Covid Community Response Survey,

both which allowed community members to share their thoughts and needs. This greatly assisted emergency responders in strategizing resource allocations and provided insight to local needs. The assessment and survey were completed this summer, then a follow-up assessment was opened in the fall and we are currently awaiting that report.

SWOTRO Happenings

Changes have taken place in the SWO research office prior to this year. Former Research Specialist, Heather Larson, resigned but remains a part of the LRRB while taking on a new role in the SWO higher education community. Siyo Peters was hired in August and is the current Research Specialist. She has adapted quickly to her new role in the SWO research community and continues to develop her understanding of researches impact on sovereign tribal nations while building important networking relationships.

Currently our sights are set on a partnership with Fond du lac Band of Lake Superior Chippewa research office and the Native American Community Clinic (NACC) of Minneapolis on a Native American Research Centers for Health (NARCH) project. If this project is approved, then we will participate in both a NARCH capacity building project, meaning our tribe will be assisting in the development of a safe and secure data repository for area tribes. And, reviewing a NARCH community based participatory research project to obtain relevant ecological health data. This would be a multi-site project with the SWO LRRB overseeing the entirety of the project for our community site. The benefits of our involvement include criteria and goal setting specific to our unique tribal needs. A research project developed with and for our SWO members paired with the experience and resources of research professionals could greatly nurture current goals and visions for the future of our Oyate.
