Tribal partner will be assigned a SWO Mentor account for the following notification purposes:

- ⇒ Protocol submitted for review
- ⇒ Communicate with researcher & Research Office if necessary
- ⇒ Protocol review status, including permit offered
- ⇒ Amendment submitted for review & resulting determinations
- ⇒ Adverse situation has been reported and resulting action taken
- ⇒ Deviation has been reported and resulting action taken
- ⇒ Pre-publication/presentation Requests submission & review determinations—Partner may share input for review consideration
- ⇒ Closeout process status & scheduled presentation —Partner may attend & share comments

Research is more than scientists in lab coats running tests. It also includes the following:

- Surveys and questionnaires
- Interviews and focus groups
- Analyses of existing data or biological specimens
- Epidemiological studies
- Evaluations of social or educational programs
- Cognitive and perceptual experiments
- Medical chart review studies

SWO Tribal Partner's of Research

Researchers intending to collect data regarding the SWO of the Lake Traverse Reservation must find a collaborating Tribal entity – agency, program, department, etc. before pursuing LRRB review.

Initial Application Checklist

All new applicants must complete the <u>initial application</u> for review of their research proposal by the Local Research Review Board (LRRB). Research proposals and new applications must contain (at least) the following items to be considered complete.

- ☐ Cover letter attached
 - Must also include a short abstract of no more than 200 words (specifically labeled).
 - If approved project, this abstract will be entered on our Research Office's website.
- The Tribal Entity Letter of Partnership, letter or LOP fillable form, is attached (e.g. Tiospa Zina Tribal School, Office of Environmental Protection, SWO Head Start Program, SWO Health Administration).
 - This is needed prior to pursuing a review from the LRRB as a cooperating partner.
 - ❖ The pre-review process by the Research Specialist/LRRB Coordinator will not initiate until

Tribal Partner Specifications:

- ⇒ Delegate an official research partner contact person > to be assigned an Mentor account
- ⇒ Submit a signed & dated *Letter of Partnership*, **not** a letter of support
- ⇒ If necessary, send notice of change of partner contact person to the Research Office

Researchers may need to submit letters of support from other entities. Research partner might assist with reaching out to other entities for these letters.

Scope & Nature (As found in the SWO Research Code Ch. 77):

Researchers seeking to conduct research in tribal communities must respect and understand the unique concerns and approval procedures specific to the SWO, in order to proceed in an ethical and culturally sensitive manner. They must recognize that they are working on sovereign lands and that cultural and legal issues differ from those in their own community or academic setting. They must become informed about the requirements set in place of the SWO. *They must also ensure that the appropriate Tribal representative(s) or group(s) have issued approval, in writing, before proceeding with any research activities.*
